Update on Enrollment

Vice President Sina Ruiz reported semester credit hours are up for Summer I by 451, Summer II by 1,610 and achieved 25% of its goal. Continuing Education third quarter goal was achieved and added an additional 2,849 contact hours. The fall enrollment is down by 8.12% from the same time last year. Following VP Ruiz report, she shared 2024 Commencement dates and times.

Finance and Operations

Vice President Teresa Thomas presented the March Financial Statement for approval. Budget amendments For March 2024 totaled \$8,491 of which \$5,440 were to increase Kids College and \$3,051 for Law Enforcement Office Standards and Education.

As of March, for the E&G fund we have received \$14.8 million (76%) of student income, \$391,000 (77%) of Continuing education income, \$6 million (102%) of local appropriations, \$12 million (74%) of state appropriations, \$1.1 million (39%) of federal grant projects, \$189,000 (43%) of state grant projects, \$13,000 (10%) of local grant projects, \$1.3 million (58%) of local income-other sources and \$34,000 (87%) of local income-sales/ services totaling \$36 million (75%) of revised budget.

The Debt Service Fund year-to-date ending March 2024 has received \$2.1 million, Auxiliary Fund \$7.7 Million (75%), and Student Financial Aid \$19 million (72%). Total income received year-to-date as of March 2024 is \$65 million (75%) of total revised budget.

The year-to-date disbursements for the E&G Fund are \$27.6 million of total revised budget of \$47.8 million

A comparison of the year-to-date revenue budget (amended budget) for March 2024 to the actual month to date revenue shows that we still have \$11,819,296 of revenue to collect in Educational and General, and \$2,4 million of Auxiliary income to collect., Resource allocations for the general fund show that we have not spent \$20 million of the revised budget in General Operating, and \$3.4 million of the Auxiliary budget.

Trustee Seely made motion to approve the March 2024 Financial Statement and Trustee Aldama seconded the motion. The motion passed unanimously.

Senate Bill 17

Dr. Fegan presented a PowerPoint showing requirements for compliance with Senate Bill 17, which will require us to certify to the Legislature and Texas Higher Education Coordinating Board by August 31, 2024 that the institution is in compliance with SB17.

Vice President Marcy Ballew stated that we are in process on working with Central Texas HR Consortium on adopting policies and procedures for appropriately disciplining, including by termination, an employee or contractor of the institution who engages in conduct in violation of Tex. Educ. Code 51.3525.

Vice President Teresa Thomas shared Senate Bill 17 financial procedures: To ensure full compliance with Tex. Educ. Code § 51.3525, in the past fiscal year Navarro College has conducted the following.

The Business Office will review the justification for purchase orders as they are processed. Any purchase order that is received by the Procurement Officer that is questionable will be reviewed by the VP of Finance prior to the procurement officer's approval.

- Cannot preference race, sex, color, or natural origin.
- Events must be structured from the standpoint of education.
- An event cannot be restricted to a specific group, must be available for everyone to attend.

When monthly financials are processed, a transaction report will be run and verified. Any questionable transactions will be reviewed by the VP of Finance. In addition, the Business Office will work in conjunction with our external auditors to ensure the college is compliant. Instances of non-compliance will be reported to the District President and Human Resources.

Dr. Fegan mentioned to the Board that the President of TACC Mr. Ray Martinez and wife Beth will tour our facility and join the Board for dinner on May 30, 2024. He then thanked the Board for recognizing the students, staff, and faculty.
